Job Responsibilities:

- Maintains, repairs, installs, calibrates, and commissions HVAC equipment
- Commercial kitchen equipment- Water leak detection- Fire sprinkler suppression system- Smoke control system- Cash services automated material handling system Analyzes, performs diagnostic trouble shooting, programs, repairs, and commissions the Building Automation System (BAS) sequences of operations.
- Adjusts the building environmental conditions through the BAS to satisfy building standards, customer requirements, and energy management strategic objectives.
- Utilizes a variety of tools and software to perform plumbing, mechanical, electro-mechanical, and electronic repair on building equipment.
- Purchases repair and maintenance supplies using company credit cards and prepares associated paperwork.
- Revises plans and as-built drawings as required to document facility changes.
- Valid driver's license required.
- Assumes other responsibilities as needed or assigned.

- Vocational, Trade school or equivalent experience.
